Discounted Student Registration Fees:

We have created a special, low-priced registration fee for students. A student is defined as someone who is enrolled at a post-secondary institution on at least a part-time basis (6 credit hours), and who can provide a valid copy of their student photo ID. Students are **required** to use their university email addresses when registering and must provide ICESA with a copy of their valid student photo ID by the registration deadlines listed in the table on page 1 of this document. Group Registrations:

If you are registering multiple people, you may do so one by one on Eventbrite (if paying by credit card) or you may use the attached registration form to pay by check. One check can include payment for multiple people, but you **must** fill out the attached registration
